# Pilot Waiver

Paragliding is a dangerous sport. which may result in injury or death. Permission to use the State of California and County of Marin Departments of Parks and Recreation Mt. Tamalpais Site facilities ("SCCM-MTS") does not in any way imply that the facilities are safe for the intended use. Adherence to "SCCM-MTS" rules and guidelines should not in any way be construed by the pilot to guarantee his/her safety. The pilot understands the risks and assumes all liability for accidents that may occur, and expressly indemnifies and holds harmless the Released Parties (as hereafter defined).

AGREEMENT AND RELEASE OF LIABILITY (initial here \_\_\_\_\_)

In consideration for being permitted to utilize the facilities and equipment of SCCM-MTS, and to engage in the sport of paragliding, solo flight, and related activities (hereafter collectively referred to as "paragliding activities"), I hereby agree as follows:

1. I hereby RELEASE AND DISCHARGE (initial here \_\_\_\_\_) the California State Department of Parks and Recreation, the Marin County Department of Parks and Recreation, the United States Hang Gliding and Paragliding Association, the Marin County Hang Gliding Association, the officers, directors, elected officials, agents, employees, instructors, pilots, assistants, fellow club members of all the foregoing, and the owners of the facilities and the land used for paragliding activities (hereafter collectively referred to as the "Released Parties"), from any and all liability, claims, demands or causes of action that I may hereafter have for injuries and damages arising out of my participation in paragliding activities, including but not limited to losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES (initial here \_\_\_\_\_)
2. I further agree that I WILL NOT SUE OR MAKE A CLAIM against the Released Parties for damages or other losses sustained as a result of my participation in paragliding activities (initial here \_\_\_\_\_), and I also agree to INDEMNIFY AND HOLD THE RELEASED PARTIES HARMLESS from all claims, judgments, and costs, including attorney's fees, incurred in connection with any action brought as a result of my participation in paragliding activities (initial here \_\_\_\_\_).
3. I understand and acknowledge that paragliding activities have inherent dangers that no amount of care, caution, instruction, or expertise can eliminate, and I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN PARAGLIDING ACTIVITIES, WHETHER. OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES (initial here \_\_\_\_\_).
4. I have been advised and recognize that my paragliding activities are not covered by any personal accident or general liability policy issued to the Released Parties (initial here \_\_\_\_\_).
5. I hereby expressly recognize that this Agreement & Release of Liability is a contract pursuant to which I have released any and all claims against the Released Parties resulting in my participation in paragliding activities including any claims caused by the negligence of the Released Parties (initial here \_\_\_\_\_).

I HAVE READ THIS AGREEMENT AND RELEASE OF LIABILITY. I FULLY UNDERSTAND ITS CONTENTS AND MEANING. AND SIGN IT OF MY OWN FREE WILL.
